*A permanent log of every person who has served the Tripp-Jones Family
— maintained by the Secretary & Family Historian*

1. Purpose

This Record is the permanent, official log of every officer who has served the Tripp-Jones Family. It is maintained jointly by the Secretary (for accuracy) and the Family Historian (for archive and legacy purposes). This record honors our leaders, supports transition planning, informs election eligibility (term limits), and preserves institutional history.

2. How to Use This Record

After each election or appointment, the Secretary adds a new entry for each incoming officer. When an officer leaves, the Secretary records their end date and a brief service note. At each reunion, the Family Historian reviews the record and incorporates it into the family archive.
